You will apply for a Certficate or Diploma, depending on the subject chosen.

Eligibility criteria

- 1 Candidates must be aged 19 to 23 years old on commencement of course (and must be born before 01/09/1999 to qualify in this funding year)
- 2 Candidates must have been UK/EU Residents for 3+ years
- 3 Candidates must NOT already hold a full qualification at the level they wish to study i.e. for Level 2 qualifications, candidates must not hold a Level 2 vocational qualification in another subject nor have more then 5 GCSE passes at Grade C or higher

Usually your trainer will visit every four to six weeks providing 1-2-1 assessment in your workplace. These qualifications usually take 6 to 9 months to complete.

- 1 You are contracted to work a minimum of 16 hours per week, and have a permanent contract of employment.
