### **Vivonio – The company**

Vivonio Furniture GmbH, established in 2012 in Munich, is a group of leading European furniture manufacturers. With seven subsidiaries, eight factories and 1,800 employees, Vivonio generates a group annual turnover of 400 million euros.

The Vivonio subsidiaries MAJA, Staud, Leuwico, Noteborn, fm Büromöbel and KA Interiør are among the leading manufacturers in their respective segments. In the main factory in Kasendorf, Upper Franconia, MAJA manufactures home office systems, media furniture, and storage furniture. In the highly automated and innovative high-performance factory in Wittichenau, Saxony, the company produces chests of drawers, drawer units, and lightweight shelves. The well-established Vivonio subsidiary Staud in Bad Saulgau, Upper Swabia, makes bedroom furniture with a particular focus on sliding door wardrobes. Leuwico, an office furniture manufacturer from Coburg is a specialist for ergonomic working environments. The Dutch company Noteborn manufactures in Heerlen made-to-measure innovative storage space solutions. With its extensive and high-quality range of office furniture fm Büromöbel offers intelligent solutions for the office and working environment. Newly added KA Interiør uses the latest technology to make made-to-measure sliding door cabinets in Denmark.

The companies within the Vivonio Group supply all the relevant, major furniture chain stores in Germany and Europe. With its MAJA production site in Wittichenau, Vivonio is one of the largest IKEA suppliers in the world.

### **Vivonio – The strategy**

The German furniture market is rather saturated and is developing at low growth rates on the whole. In this environment, the companies within the Vivonio Group have succeeded in gaining market share and increasing turnover: The reasons for this success include modern product portfolios and innovative product development among the subsidiaries, as well as extremely efficient production, most notably at the highly automated high-performance factory in Wittichenau.

With their product range, the subsidiaries are positioned in the lower middle or middle of the market – market segments that show signs of stable growth.

These favorable conditions are the basis for the further expansion of the Group through organic growth of the individual subsidiaries and by means of targeted acquisitions. The turnover of the targeted companies should be between 30 and 200 million euros and usefully supplement the product portfolio and locations of Vivonio. As a result of these acquisitions and investments in the subsidiaries that already exist, Vivonio is aiming for a group turnover of up to 500 million euros in the medium term.

Part of Vivonio's strategy is to maintain the independent market presence of its subsidiaries, to strengthen their image and market position, and to open up additional markets for them. In purchasing and international expansion, the subsidiaries are working closely together to exploit synergies and reap the benefits of a strong group of companies.

- The Vivonio subsidiary MAJA specializes in the production and sale of flat-pack furniture. In close collaboration with customers and designers, MAJA designs high quality mass-produced furniture and exclusive models with innovative hardware technologies that can be perfectly combined together due to their modular design.

## **Vivonio – The high-performance factory in Wittichenau**

Between 2012 and 2013, MAJA invested over 60 million euros in a new lightweight furniture factory at the site in Wittichenau, and created more than 200 jobs. The production and warehouse area has more than doubled as a result of this investment: From 40,000 square meters to over 85,000. The production engineering start-up phase is now complete: In addition to the established IKEA products Malm and Alex, the Kallax shelving unit (formerly Expedit) is now also produced there – the shelving unit is made entirely of lightweight materials there.

## **Vivonio – The owners**

The majority shareholders of Vivonio are investment funds managed by Equistone Partners Europe. Consequently, Vivonio has a financially strong majority shareholder with experience of SMEs that supports the growth and expansion plans of the group of companies in the long term. In addition to the Equistone funds, funds managed by Orlando Management AG as well as the management also hold a stake in the group of companies.
