



## Old Field Club

### Credit Card Payment Agreement

The Undersigned is a member of the Old Field Club and requests the opportunity to pay membership dues, cabana fees, minimum fees, tennis fees and any and all other fees and charges due from the Member. The Old Field Club will waive its customary 2.5% fee provided the Member maintains a valid Mastercard or Visa card on file and once this Credit Card Payment Agreement is approved, the Member agrees to the following:

**1. Dues, Cabana Fees, and Shed/Storage Fees:**

Member agrees that the Old Filed Club may charge the Member's credit card on file for any and all Membership Dues, any Cabana and/or Shed/Locker fees (this includes any sublet or boat storage fees) ("Annual Fees") charged to the Member. The total of all fees will be divided in three (3) and one third (1/3) of the total fees will be automatically charged on the 10<sup>th</sup> day of the months of January, February and March.

**2. Monthly Charges:**

Member agrees that the Old Field Club may charge the Member's credit card on file for any and all monthly charges and/or other charges incurred by or on behalf of the Member, including without limitation charges incurred at the Club Restaurant, Club Bar, Club House, Pavilion, Food Truck and/or Beach. This includes charges incurred for Old Filed Club special events and functions.

**3. Tennis Charges:**

Member agrees that the Old Field Club may charge the Member's credit card on file for any and all charges incurred by or on behalf of the Member, including without limitation charges incurred at the Tennis Pro Shop, Tennis Courts and Food Truck. This includes charges incurred for tennis lessons, Old Field Club apparel, and Old Filed Club special tennis events and functions.

**4. Other Charges and Fees:**

If at the time of submitting this Credit Card Payment Authorization, the Member has any open invoices, accounts payable and/or delinquent amounts owing from the Member prior to the signing of this Credit Card Application, then Member agrees that the Old Field Club may charge the Member's credit card on file for any and all prior charges incurred by or on behalf of the Member and/or owing by Member to the Old Filed Club.

Member agrees to keep a valid credit card on file and immediately replace any card that is invalid and/or expired.

Member acknowledges that this Credit Card Payment Agreement is an accommodation and service offered by the Old Filed Club and it can be revoked by the Board at any time.

If for any reason the Member's charges, dues and fees are not, or are unable to be paid by the Member's credit card, then Member acknowledges and agrees that those charges and fees are still owing to the Old Filed Club.

The Member may question any charges on their bills made by the Old Filed Club. All questions about any charges should be made as soon as possible but at least prior to the next monthly billing cycle. If an error is found to exist, then the Old Filed Club will issue a credit back to the Member.
