# Old Field Club 2016 Annual Meeting President's Report Mark Geraci

Good evening everyone and welcome to the 2016 Annual Meeting of the Old Field Club. What a great way to end our season these past few weeks. Beautiful weather, great and extremely well attended weekends at our Seahorse Grill, the Pavilion and our new Food Truck, and also during our expanded Happy Hours at the Beach Bar, at Movie night for the kids at G-Court, at exciting tennis matches and at the always wonderful awards dinner ceremony. These events are just a few examples of what makes the OFC such a very special place to all of us.

Since our 2015 Annual Meeting your Board of Governors addressed a number of issues and challenges and I feel accomplished much, creating even greater value to all Members, and for our extremely important Catering Operations. Let me begin by briefly highlighting some of our Major Accomplishments for this year:

- The continued improvement of our financial position and strong catering performance.
- Spending approximately \$325,000 on much needed Capital Improvements throughout the Club.
- No Member dues increase for 2016 and continued Bond Redemption.
- The resolution of a number of critical regulatory matters.
- The opening of the Beach and Cabanas even earlier in April.
- The addition of 12 new Young Adult Members and finally a Waiting List for those interested in joining our Club.
- The addition of a golf membership with Port Jeff Country Club.
- Significantly increased Tennis activity.
- Our five complementary Member Only events.
- The launching of our redesigned Website.
- The creation of 13 new lockers at the Beach and
- The restoration of our Beach sand!!

Now for some specifics let me start with our Clubhouse.

# The Clubhouse:

This year's improvements and enhancements, along with what has been done over the past few years, have added considerable value to the Club. It was and has been, critical for us to tackle these projects for two primary reasons; the first was obviously for member enjoyment. The second was to make our Club even more attractive, and better able to compete in the highly competitive Catering business market. As most of you know, Catering is the major source of revenue for the Club and allows us to keep Membership dues fairly reasonable, and for us to invest in a number of important ways that improve the value of our Club for all Members.

This year we spent approximately \$17,500 on a new Kitchen Floor, approximately \$12,000 on a New Hood System, and another \$8,000 on New Kitchen Equipment. In the Ballroom we spent approximately \$4,000 on New Paneling and about \$3,000 for New Lighting.

In the Lagoon Room we reconfigured the decking for about \$4,000, installed a new ductless air conditioning unit for approximately \$6,000, and spent approximately \$9,500 on new flooring and carpeting.

Finally at the Clubhouse we added two new awnings for a total cost of approximately \$31,000. Upgraded the Wi-Fi system for about \$2,000 and replaced three Beer Tap units for approximately \$3,000.

# **Catering Operations:**

This year our Catering Operations will likely meet or exceed our revenue forecast of \$1,734,000, and 2017 booked events appear to be trending as well as this year, thus helping to insure that the Club's financial positon will continue to improve. As I mentioned before, we believe that these positive developments, despite strong competition and the economy in general, were a direct result of years of careful planning and needed investments, as well as the outstanding work of our

superb management team, led by Dennis, Sabine and Chris -- Great Job!!

One of our most significant challenges was addressing a number of long standing "regulatory" matters involving the Town and the DEC that had a direct and meaningful impact on the Clubhouse and our Catering operations. Broadly stated, these involved, and have involved, the lack of approved use of the Clubhouse as a catering establishment and the "non-permitting" of the Lagoon Room. We retained appropriate counsel and a DEC consultant and I am pleased to report that most of these issues have now been resolved. This could not have been accomplished hadn't not been for the considerable engagement of Board Members, Tim Glynn and Joe Troffa, along with Dennis Manarino.

All of these undertakings, improvements and expenditures at the Clubhouse and Lagoon Room have been part of our strategy, and my personal goal, of "Strengthening our Foundation and Building for our

Future." These were all extremely important and necessary steps to help us achieve these goals. Very special thanks are in order once again to those Board Members who helped to make so much of this all possible by voluntarily dedicating their considerable time, extraordinary efforts, insights, and free professional expertise. Those members are Louise Mercer, Bob Brennan, Joe Troffa and Tim Glynn.

# Pavilion/ Seahorse Grill / Beach Bar

There's no question that all the hard work, investments, continuous improvements and new ideas over the past few years, at the Pavilion/Sea Horse Grill/ Beach Bar have been a huge success with our Membership.

Speaking of investments, this year at the Pavilion, we spent approximately \$7,000 on new awning, about \$12,000 for a new kitchen hood system and approximately \$2,000 for new patio furniture.

I am pleased to announce that beginning on October 1<sup>st</sup> we will be continuing to offer dinner service at the Seahorse Grill and Pavilion on Friday and Saturday nights until Thanksgiving. We will again move the Beach bar up to the Pavilion and reconfigure the area to accommodate Dinning, and Happy Hour. Just a few years ago who would have ever thought that a wonderful, Fall, Beach Dinning experience would have been possible at the OFC – Thank You Tim Glynn for your long term vision!

John Fondacaro, Tim Glynn's co-chairman at the Pavilion will go into further detail concerning the successes, and of course challenges, we experienced at the Pavilion/Seahorse Grill and Beach Bar. However, let me add that to further enhance our Member's experience we purchased a Food Truck — a big hit already, for approximately \$42,000, and built a walkway to the Food Truck from the Bar for about \$2,500. The Food Truck, we believe, provides us with a great deal of flexibility to do a number of new and interesting things for our Members for years to come.

# **Member Social Events**

Norma and Teri will share with you shortly the highlights of this past year's Member's Social calendar. However, I would be remiss if I didn't at least mention the tremendous success of our Free, Member-Only events. Specifically Saint Patrick's Day, the Governor's Ball and the Summer Beach Party, all of which had over 150 Members attending----Outstanding! And we still have our Halloween and Christmas parties to look forward to — Great job ladies!

# **Beach**

At the Beach, Cabana and flooring improvements continued, and we did our best to prioritize and address as many ongoing repair issues as possible, while simultaneously dealing with the major loss of sand at the Beach early this year. As requested, Cabanas were opened even earlier this year for the enjoyment of many of our Members who like to start the "Season" a bit earlier. And although not perfect, our OFC staff did a fine job in keeping the overall area relatively clean, a

particularly difficult task given the high amount of traffic on the weekends throughout the course of the season.

As most of you know our most significant challenge this year at the Beach was the result of considerable erosion and loss of sand. However, we were fortunate to have the expertise and dedication of Joe Troffa to rely on, and with the help of other Board Members such as Steve DelGiorno and Bob Brennan the Beach was restored, and Cabanas were salvaged! Extraordinary work guys, thank you so much! The cost to accomplish this was not insignificant – around \$60,000 – however, this would have been considerably more if it hadn't been for these Board Members. And in addition to this, they put in a Beautiful New Handicap Ramp and Walkway at the Beach for about only \$2,400.

# Membership

Last year I mentioned to you that over the last 10 years we experienced a significant decline in our overall Membership. Some of this attrition was planned;

however, the decline was worth noting. In 2005, the Club had a total of 239 Members, and 10 years later, our Membership was at 199. In addition, in 2005 we had a healthy Wait List of 24 families and individuals. In contrast, by the end of 2015, we really had no one on our Wait List. The Board recognized that there were always a number of factors that affect our Club's membership, such as the economy, the cost of dues and fees, Cabana wait list times, etc. However, the actions we took last year, particularly approving a By-Law change affecting Young Adult Members has had a significant positive result. This year 12 New Young Adult Members joined the Club. Isn't wonderful to see, once again, so many young families and their children thoroughly enjoying the Old Field Club? There is no question that these new members are the "Future of our Club" and will help "Strengthen our Foundation" for many years to come.

# **Finance**

Throughout my opening remarks I have provided you with a number of examples of this year's Capital Expenditures and the Club's overall financial position.

Greater details will be provided to you by our treasurer, Rob Kent, in his report, and our CPA, Thomas Novak is here to answer any specific questions you may have. As I mentioned, we anticipate that capital spending alone this year will approach \$325,000. This type of investment is only made possible because of the improving financial position of the Club, primarily driven by our successful and profitable Catering Operations.

As I mentioned last year, during my first tenure on the Board, ending as President in 2008, I never dreamed that the OFC would ever be in such a positive financial position – but here we are. Still, much work needs to be done and we absolutely must have a successful and robust 2017 Catering Operation to "Build for our Future."

I would like to end my opening remarks with a very special Thank You to all my fellow Governors. Those of you who have served on the Board of the Old Field Club in the past know that these are truly thank-less jobs. However, what I learned during my first 10 years and

now during my last two years on the Board serving as your President, is that all Board Members give so generously and so freely of their time purely out of their love of our great family Club. Make no mistake about it, the Old Field Club is a very special place. My sincere hope is that we can keep it this way for many years to come. Rest assure that your 2016 - 2017 Governors seated here tonight share that same sentiment and a keen sense of responsibility that we owe it to the Club to give something back - because it has been so very good to all of us and our families. Your Board welcomes all fellow Member input, constructive comments and suggestions because we know that these are always made with the Club's best interest in mind. I have the upmost confidence that your Board will continue to work hard to make all of our Old Field Club time together even better, and we will do whatever we can to ensure the financial stability of the Club, while at the same time provide all our Members and guests with truly memorable experiences.

It has been an honor for me to serve, once again, as President of the Old Field Club these past two years, and I hope like every President before me since 1929 that I have made our Club, this Club that I love, just a little bit better. Thank You!

# FINANCE COMMITTEE REPORT

# **Finance Committee Executive Summary**

Since the last Membership meeting, the OFC has suffered through some significant events which put a strain on the club's finances this year. Most particularly, the beach suffered several extreme erosion events, causing damage not only to the beach, but to a number of cabanas and the lifeguard station. Unfortunately, the events were repeated, after certain repairs had been completed, causing additional repair costs. As such, in addition to the capital expenditures we had planned for 2016, for the main club house, including mandated changes to the Lagoon Room, expanding the cover on the rear deck, and for improvements at the beach and pavilion including purchasing the food preparation trailer and installing the new storage sheds (or she-banas), we incurred significant expense to repair the beach. However, because of the progress made towards improving the balance sheet and fiscal health of the club, we were able to absorb these unexpected events without any member assessment or without any borrowing.

In addition to the capital improvements made, and emergency repairs undertaken, we were able to continue to redeem member bonds further improving the balance sheet.

Of particular note is that all of the above was accomplished with a dues increase in 2016.

The improved financial condition of the club has occurred primarily for the following reasons<sup>1</sup>:

- Steady and increasing catering revenues
- Increased revenue from club dues and sales to members
- Capital improvements at the club
- Implementation of departmental annual budget process

The board, with support of club membership took steps to support and increase catering sales and revenues. We retained the services of Dennis Mannarino, in a consulting role, to ensure continued success of the club operations and catering success. We continue to implement many recommendations to increase club quality and the club experience. We approved improvements at

the Pavilion, including expanding the dining areas, adding the food trailer to handle increased food demand, and lower wait times and made other noticeable capital improvements to increase member experience.

Finally, the board undertook a necessary and well researched review of necessary capital improvements necessary to maintain and/or increase the quality of the club, and the club experience. This includes implementing a robust budgeting process, clearly delineating between operations and capital needs. You will hear from the various committee chairs about the specifics of the capital improvements. These recommendations were made for a variety of reasons, including safety, energy efficiency, asset preservation, or increased revenue. For example, the board approved installation of a ramp to the Pavilion making access easier for those members and guests needing to avoid the stairs to gain access to the improved Pavilion restaurant. Improvements to the club house, beach, tennis courts and pavilion are providing a better club experience for members, encouraging more consistent and higher valued catering revenue, and most importantly upgrading the facilities for future longevity and energy efficiency.

Final 2015 and current 2016 financial summaries are available for your review.

**Specific Summary from Reports** 

### Conclusion:

Because of the increased financial condition we have continued a course of action in 2016 to increase fiscal health, yet continue to provide an excellent experience for members.

We have completed and are completing several additional capital improvements that will be described by the committee responsible.

We have eliminated the unfunded liabilities (party deposits) and now have positive retained earnings/equity

We have redeemed a significant amount of member bonds.

We approved additional "club funded" functions for members to increase the club experience, encourage club use and give something to the membership for its support.
