

## **OPEN LIVESTOCK JUDGING**

State aid on premiums paid to exhibitors shall be limited to classes and amounts set forth below. The numbers listed in descending order adjacent to each class are the maximum dollar amounts for the places for which aid may be paid.

- 1. All exhibitors must be 8 years of age as of January 1<sup>st</sup> of the current fair year.
- 2. All purebred, mature stock must be registered in a recognized American Registry Book, and be prepared to show proof of registry.
- 3. No animals having hereditary unsoundness will be allowed to compete for premiums.
- 4. Pair of calves, either senior or junior class are to be bred and raised by exhibitor.
- 5. Only first prize winners can compete for championship. No entry required.
- 6. Premiums will not be paid on exhibits removed from the fairgrounds before 4pm on Sunday.
- 7. All exhibits must be removed from the fairgrounds between 4pm and 6pm Sunday unless other arrangements are made with the superintendent prior to show.
- 8. Exhibitor is responsible for cleaning of stall and area.
- 9. Only one entry per lot number is allowed by an exhibitor.
- 10. No animal shown in Junior Classes can be shown in Open Classes.
- 11. Absolutely no damaged or repaired extension cords allowed.
- 12. Exhibitors must have all required forms filled out completely, and turned in to appropriate superintendent before they will be allowed to exhibit their project(s).
- 13. Anyone presenting awards or ribbons for any of the livestock shows must be at least 8 years old.

## OPEN LIVESTOCK CLASSES – PLEASE ALSO SEE HEALTH REGS UNDER RULES & REGS

- Premises IDs are REQUIRED for all livestock showing at the Fair. This includes dairy, beef, swine, sheep, poultry and horses. Rabbits, dogs and cats do not require a Premises ID. No livestock will be admitted on to the Fairgrounds without a valid Premises ID on file with the Fair Office. If you have animals at more than one location, please provide Premises IDs for all locations. For more information on applying for a Premises ID, visit www.wiid.org.
- 2. All entries close June 22<sup>nd</sup> of current Fair year. Premium Books will not be printed. Entries can be done online at <a href="www.lodiagfair.com">www.lodiagfair.com</a>. Reference Premium Books and Entry Worksheets are located at the Lodi Library and the Poynette Library. Fair Office personnel will offer entry assistance during Office Hours as indicated on the front cover of this Premium Book.
- 3. Livestock exhibitors must verify number of animals needing stalls on or before June 29 by replying to the stalling request email from secretary@lodiagfair.com. Exhibitor email addresses from the exhibitor's blue ribbon online entry account will be used. Note: failure to respond will delay stalling of animal exhibits.



- 4. Barn set up time is Wednesday from 5pm to 8pm. After 8pm on Wednesday the barns will be closed until 2pm Thursday. Note: swine exhibitors will be penned upon arrival.
- 5. Junior and Open General Exhibit drop off is Wednesday from 4pm to 8pm and Thursday from Noon to 6pm.
- 6. Swine exhibitors will be given a stall assignment upon check in. No swine should be stalled until a stall is assigned.
- 7. Livestock exhibits: dairy, beef, swine, poultry, rabbits and sheep are to be brought in between 2pm and 6pm on Thursday. Market animal weigh ins (beef, sheep & swine) will be from 6:30pm to 8pm Thursday.
