To **estimate** your 2019 tax bill (payable in 2020), divided the assessed value of your property by 1,000. Then multiply that amount by the Mill Rate for the school district you live in.

Examples:

Sauk Prairie School District: \$200,000 home / 1,000 = 200. 200 x \$15.90 = \$3,180* Baraboo School District: \$200,000 home / 1,000 - 200. 200 x \$15.97 = \$3,194*
